

# HOW TO ORDER YOUR TESTS FOR 2020:

**IMPORTANT: Read ALL instructions and information in this brochure. Read carefully and follow these INSTRUCTIONS to complete the form:**

- List your family information in the spaces provided on the ORDER FORM below.
- Refer to **Table 1**. Find your child's **Grade Level** and the corresponding **Test Level**.
- Find your nearest **Area Coordinator** in **Table 2**, and **write this name** in the box provided. For **private testing** *not* through a coordinator, write "**Private**" in this box.
- For **private tests** (read paragraph on back), write your tester's name and contact info in the space provided (lower left corner ★), and provide your expected **testing date**.
- Check your membership status. Find your expiration date on the mailing label of this brochure. If you join or renew when ordering, *take the member discount now*. (See explanation on other side.)
- Figure your fees. Using **Table 3** below, start in the first box with \$40. **Circle** fees and discounts that apply (see **2020 Deadlines and Fees** box), add and subtract to find **TOTAL PER TEST**, then **multiply** by number of tests ordered to find **FAMILY TOTAL**.
- Make check or money order **payable to WVHEA** (separate check for membership).
- Mail your order by deadline to Area Coordinator** (to state coordinator if private test). **DO NOT** mail to WVHEA's PO Box. **TIP:** Follow up a few weeks later to make sure the coordinator received your order.

## 2020 DEADLINES AND FEES

- 1-15-2020 Subtract \$5 *early-bird discount* if **paid in full** by this date.
- 2-15-2020 Add \$10 *late order fee* for orders after this date.
- 2-28-2020 Order **STOP DATE. No orders** accepted 3-1-20 through 5-1-20.
- 4-22-2020 Last day to return completed tests for machine scoring.
- 5-1-2020 Begin orders for May-June tests.

# TESTING WITH WVHEA 2020

This brochure contains the information you'll need to order standardized tests through WVHEA for 2020. **Please take time to read it carefully before completing your order form.**

**About WVHEA.** West Virginia Home Educators Association is a 501c3 nonprofit organization of homeschooling parents serving other homeschoolers. Standardized testing is one of its services. Area testing coordinators **volunteer** their time to organize testing within local area groups. If you need help with ordering or have other questions, contact the nearest area coordinator or the state coordinator (contact information inside).

**WVHEA Membership.** You don't have to be a WVHEA member to order tests, but the annual fee is only \$15 and members get a \$10-per-test discount, plus online newsletters and special mailings. Membership is open to all WV homeschoolers regardless of their reasons for homeschooling.

Your member expiration date will be printed on your label. If no date is shown, it means your membership has expired, or you are not a WVHEA member. You can join or renew for one year by including a separate check with your test order, or pay online at [wvhea.org](http://wvhea.org).

**WV Law.** WVHEA Testing Service is fully compliant with WV Code §18-8-1(c)(2)(C), providing for annual assessment using a nationally normed standardized achievement test.

**TerraNova.** WVHEA uses the *TerraNova Third Edition*, with special permission from its publisher and the WV Dept of Education. The *TerraNova3* was published in 2008, normed in 2017, and provides scores in the subject areas required by WV law.

**Test administrator requirements.** All testers must document specific training in standardized test administration within the past 5 years and must agree in writing to observe publisher's guidelines and related policies of WVHEA.

**PLEASE NOTE:** Although a 2016 change in WV law allows parents to test their own children, to comply with publisher guidelines WVHEA **does not** sell *TerraNova* materials directly to parents for private administration.

**Testing fees.** WVHEA fees cover costs of testing materials, scoring, and operating expenses, and are not intended for profit-making. The basic per-test fee is \$40, and you can reduce the cost to as little as \$25 with discounts (early payment, membership). Late orders, private testing, and hand-scoring incur additional fees. Our fees do not include local costs for site rental or private testers. Use **Table 3** to calculate.

**Order cancellation.** A \$5 processing fee will be deducted from any refund requested by parent.

**Group testing.** Group testing through area testing coordinators around the state provides an opportunity for families to help each other with testing and keeps costs low. If you test with a private group, please send your order to your group's coordinator.

**Private testing.** If your child is tested privately, you must pay the \$10 private testing fee to cover costs, even when ordering through an area coordinator. If your coordinator does not handle private tests, send your order directly to the state coordinator. When testing privately, it is *your* responsibility to locate a tester who meets WVHEA requirements.

**Late testing.** If you do not plan to complete testing by **April 24, 2020, DO NOT** send your order until after May 1. Submit late orders to the state coordinator, not the area coordinator.

*Remember, area groups work best when all parents contribute. If your child is being tested, you should be helping to test another child.*
